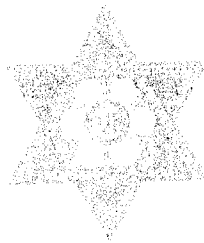

Articles on Social Sciences and Humanities on Nepal are published in this Journal. Papers, review articles and short reviews of new books on Nepal are welcome from both Nepali and foreign contributors.

Articles should be original, written in either English or Nepali language.

They should be neatly typed in double-space leaving a margin of 1½" on either side of the page.

References cited and other notes should be given at the end of article and reference numbers in the text should be given in sequence.

References cited should be complete, with the full name of the author, full title of the work, publishers' name, place of publication and year of publication. In the case of articles, the full name of the journal or magazine referred to should also be given, as well the page numbers in which the article appears.

Editors reserve the right of refusing to publish papers submitted to it without giving reason.

Published articles are remunerated, but the CNAS retains the copyright to all articles submitted.

The opinions expressed in the articles or reviews are the author's own and do not necessarily reflect the views of the publisher or the editorial board.

Photographs and line drawings can be sent for illustration purposes. Photographs should be clear, glossy prints.

Contributors of articles will receive fifteen off-prints of their article. Additional copies can be prepared on request, on a cost per page basis.
